



**SOUTH CAROLINA HIGHLIGHTS**  
**ENTRY DEADLINE: FEBRUARY 15, 2017**

**LEAGUE LEVEL QUALIFYING PERIODS:**

- I        NOVEMBER 6 to 19, 2016
- II        JANUARY 8 to 21, 2017

A)        Follow sample league worksheet to determine league qualifiers. Do not add scores together; each participant has two chances per period to qualify. Use the higher of the two scores to determine the qualifiers in each period. Reproduce the forms as necessary. Be sure to keep a copy for your records.

Qualifying competition is held in divisions based on the bowler's age as of the dates below:

- U8 Boys & Girls        Bowlers whose birthdate is 08/01/2008 or later
- U10 Boys & Girls        Bowlers whose birthdate is 08/01/2006 thru 07/31/2008
- U12 Boys & Girls        Bowlers whose birthdate is 08/01/2004 thru 07/31/2006
- U15 Boys & Girls        Bowlers whose birthdate is 08/01/2001 thru 07/31/2004
- U20 Boys & Girls        Bowlers whose birthdate is 08/01/1996 thru 07/31/2001

**DO NOT COMBINE BOYS AND GIRLS INTO ONE DIVISION.** THEY MUST PARTICIPATE IN THE APPROPRIATE DIVISION FOR THEIR AGE AND GENDER. If you are unsure in determining the qualifiers, please send me a copy of your worksheets and I will help you.

B)        **ADVANCEMENT RATIO:**

**\*\*IMPORTANT NOTE:** League officials using league secretary software to calculate Pepsi USBC Youth Championships results must set the advancement ratio option to "1-5" in order to comply with the rules and qualify the correct number of bowlers.
